5.1 **Termination by Either Party:** Either party may terminate this Agreement upon 30 days' written notice to the other party if the Event is canceled or postponed to a date that is not acceptable to the Sponsor.

5.2 **Termination for Breach:** Either party may terminate this Agreement immediately upon written notice if the other party breaches any material term of this Agreement and fails to cure such breach within 15 days of receiving notice of the breach.

6. RELATIONSHIP OF PARTIES

Nothing contained in this Agreement shall be construed to create a partnership, joint venture, or employment relationship between the parties.

7. INDEMNIFICATION

The Sponsor agrees to indemnify, defend, and hold harmless the Charity, its officers, directors, employees, and agents from and against any and all claims, liabilities, damages, and expenses arising out of or related to the Sponsor's activities under this Agreement.

8. GOVERNING LAW

This Agreement shall be governed by and construed in accordance with the laws of the State of Florida.

9. ENTIRE AGREEMENT

This Agreement constitutes the entire agreement between the parties with respect to the subject matter hereof and supersedes all prior agreements, understandings, and representations.
